## **Vendor/Business Owners Guidelines & Registration**

B & S Consignment is a children's consignment sale held twice a year in spring and fall. We hope to make it easy for you to connect with families with children that help your business thrive. The following guidelines were designed to help make the event successful for everyone.

1. Vendor/Business owners are required to submit a registration form along with your fee. Payment is required at the time of registration and will reserve your space. Please make checks payable to B & S Consignment.
2. The fee includes the services listed in your package, or the individual items you requested. For businesses renting table space, we will do our best to provide you with electrical outlets. However, we cannot guarantee it. Vendor space is a 6 foot table. Space selection will be on a first-come-first-serve basis.
3. For onsite vendors we will accept only one vendor from any major line of merchandise. For example, Tupperware, Mary Kay, Avon, etc.
4. On-site vendors may display during the three public sale days (Thursday & Friday 9am-6pm and Saturday 9am-1pm). Set up is one hour prior to the start of the sale. Vendors must be cleared out by 2pm on Saturday.
5. All merchandise/materials/services must be new and meet the approval of B & S Consignment. We reserve the right to disallow merchandise we feel is not "family friendly". B & S Consignment will not be held responsible for loss or damage of vendor merchandise or materials.
6. All sales transactions and/or contracts are made directly between the vendor and customer.
7. All onsite vendors that sell merchandise MUST collect 7% Mississippi sales tax and turn that in with a total sales amount to B & S Consignment prior to clearing out their space.
8. Goodie bag items must be received by September 22, 2009 at the Lincoln County Multi-Purpose Facility between the hours of 10 a.m. and 12 p.m. We cannot guarantee the inclusion of goodie bag items received after the deadline specified.
